Exceptional Community Benefits: The sixteen clans that make up the Tavolo Community Conservation Association (TCCA), who are project proponents and the - beneficiaries, have customary landowning rights to their traditional land; The project area is classified as a low human development country according to the UN index; 50% of the total population in the project zone are expected to have improved livelihoods or income generated as a result of project activities; minimum requirement of involvement for women of 30% for participation in work, meetings, workshops and trainings, and for representation in governing bodies and workforce; PNG Communities Benefits from Environmental Service Trust (BEST) is set up as a benefit sharing mechanism, for support to lead to long-term financial security and social benefits; Continuous capacity building and training of the TCCA.

Of these species terrestrial and marine trigger species were identified and measures to conserve their populations and habitat were formulated, as well as specific monitoring strategies. 2 of the species are endemic to New Britain.

3 SUMMARY OF MONITORING RESULTS – *SOTPELA TOKTOK LONG KAIKAI BILONG WOK SKELIM*

3.1 Climate Impacts – Oi Mak long sait bilong Klaimet

Total GHG emissions or removals resulting from project activities: Since the start of the REDD project activities 9,832 hectares have been protected from deforestation originally planned under the Mukus-Melkoi SABL. However, also 15.2 ha of forest cover loss (deforestation) was detected between 2019 and 2022 in the project area, corresponding with an estimated total of 5,049 tCO₂e of emissions. This was subtracted from the achieved emission reductions. The results of the 2022 carbon monitoring campaign shows that since the beginning of the REDD project in 2019 a total of 2,842,675 tCO₂e of emissions from deforestation have been avoided within the project area. After a buffer subtraction of 19%, 2,277,000 VCUs are eligible for issuance. See VCS Monitoring Report (separately provided).

Optional Criterion: Climate Change Adaptation Benefits: The Tavolo Community Conservation Association (TCCA) has prepared their Management Plan details on activity implementation and prioritisation, including a dedicated Theme on Climate change adaptation and mitigation with 4 associated Objectives and planned activities.

3.2 Community - Komuniti

Protection of the forest and community HCVs

In October 2019, the communities signed the Mukus-Tavolo-Lausus Conservation Deed. The PNG Communities BEST Program membership agreement between TCCA and FORCERT was signed November 2021. A Legal clearance of the PNG Communities BEST Program membership agreement, (including the Tavolo Conservation Deed) was given by the State Sollicitor's Office of PNG (November 2021). Through these activities and achievements the project strongly reduced pressure on the Tavolo Community members and their land, managed to prevent the threat of being deforested (being part of the Kakuna-Lote FCA) and received confirmation from the Government that they support the project. The project achieved assurance that their land, forest, all identified community HCVs are now legally protected, and threats to it can be taken to court.

Improved livelihoods and empowerment of women

School fee subsidies for a total of 100 students for 2020, 2021 and 2022 (with 57 of them females) were provided. This resulted in important relief to the pressure on parents of secondary school children to raise sufficient funds early in the year to guarantee their child(ren) can actually enroll after having been accepted at their school.

Housing, transportation, education- and health infrastructure

In December 2019, 2140 sheets of 14feet roofing iron were distributed to all clans of TCCA, and 120 sheets to Church and school buildings. This is the first result of the TCCA housing scheme to provide a permanent 3-bedroom house to every family in Mukus, Tavolo and Lausus. Most families currently live in bush material houses, which need to be replaced about every 3-4 years.

Empowered Community and marginalized groups

To empower the Tavolo Community, the Tavolo Community Conservation Association (TCCA) officially registered with the PNG Investment Promotion Authority on 25 January 2021. The incorporation of TCCA allowed for the formalization of the legal structure for the project with TCCA as the legal representative body of the Tavolo Community signing the PNG Communities BEST Program membership agreement with FORCERT.

Long strongim Tavolo Komuniti, Tavolo Community Conservation Association ibin kisim luksave wantaim PNG Investment Promotion Authority long 25 Janueri 2021. Dispela luksave ibin inapim TCCA long makim Tavolo Komuniti aninit long ol Lo na long saimin PNG Communities BEST Wanbel Pepa wantaim FORCERT.

A first TCCA Annual General Meeting was held with 112 people attending, of which 54% were women. Various resolutions at the meeting were moved and/or seconded by women. The successful first AGM allowed for TCCA to further prepare itself institutionally to manage the 65% community share of the project income for implementation of its Management Plan. The Tavolo Community has progressed their community organizing and self-reliance to the next level, leading to increase in confidence and pride with the Tavolo Community members.

Tavolo Komuniti igo long narapela mak gen nau long oganaism komuniti long lukautim ol yet, we emi strongim stret tingting bilong ol memba bilong Tavolo Komuniti olsem ol bai inap stret long mekim.

The TCCA developed measures to ensure participation of women, such as 1) minimum required participation of 30% women in meetings, workshops and trainings, and for representation in governing bodies and workforce, 2) management of family bank account by women and 3) equal opportunities in access to education are in place and being implemented.

Any barriers/risks of unequal access to benefits identified were used as input for the development of the Community Funds Rules, and TCCA Financial Manual and Standard Operating Procedures

3.3 Biodiversity – *Olgeta samting long bus, graun, wara na solwara*

For this monitoring period, no data was collected yet to provide an indication of the status of the specific biodiversity HCV species, indicator species or the trigger species that are included in the monitoring plan. Indirectly however, in the absence of direct observation data, we assume that the intactness of the forest (as reported in the VCS MR) and the level of compliance of the community members to the Community Conservation Laws and the Sustainable Land Use Plan also serve as indicators that the HCV species populations have been maintained during the monitoring period.

The identified loss of 15ha of forest during this monitoring period, is further investigated by the Tavolo Community. Part of the loss (7,5 ha) can be attributed to the planned establishment of food gardens by community members in line with the Tavolo SLUP. But the remaining 7.7 ha that was observed in the Forest Conservation and Forest Production Zones are not in line with the Tavolo SLUP. One small-scale non-compliance is known to have occurred on which appropriate action was undertaken. A map of the forest loss has been shared and discussed with the Tavolo Community, and further ground truthing will be done to try identify the causes for all individual areas, and decide on any further necessary and possible remedial action. This will be further discussed and follow up on during next community visits, and will be reported on by TCCA and discussed with FORCERT during the first PNG Communities BEST REDD Tavolo Project annual monitoring meeting at Tavolo village, scheduled for the end of 2022.

Wanpela mep bilong olgeta hap we bus ilus Tavolo Komuniti ikisim pinis na ol toktok long en pinis, na bai gat moa wok yet long go long olgeta wanwan hap na painim aut wanem samting ibin mekim bus ino moa stap, na skelim wanem kain wok imas na iken kamap long stretim. Bai gat moa toktok yet long dispela long ol neks wokabaut long komuniti bilong FORCERT, na TCCA bai givim ripot bilong em igo long FORCERT na toktok long dispela ol samting long taim bilong nambawan PNG Communities BEST REDD Tavolo Project kibung bilong wanwan krismas long skelim wok, na em bai kamap bipo long pinis bilong Yia 2022.

To address a potential lack of adherence to the Community Conservation Laws by members of the Tavolo Community, the TCCA clearly linked compliance with the Community Conservation laws with the rights and access to benefits for families. The other mitigation measures developed are yet to be implemented.

Also, the TCCA Management Committee agreed to allocate an annual budget to the Community Conservation Law Committee, which will allow them to implement the identified areas for improvement during their monitoring meeting with FORCERT in April 2021.

Protection Marine HCVs, and RTE/trigger species

Through the implementation of the Sustainable Land Use Plan (SLUP) and the Community Conservation Laws (CCL) and enforcement by the Community Conservation Law Committee, the development and implementation of the Community Conservation Management and Monitoring System and guidance & support for the TCCA and Community Conservation Law Committee by FORCERT and Binatang Research Centre, the Tavolo Community has successfully managed and protected the marine HCVs, indicator species, as well as RTE/trigger species
